Double Reports

The fix for the issue surrounding duplicated HPV reports was applied on the 10/03/2025; this should no longer be an issue going forward.

Any 'duplicate reports' should be checked to ensure they are not in fact amended reports.

Please log any calls with Pathology IT for what you believe to be genuine duplicated reports with NHS Number, Report ID and the date and time the report was received to be investigated thoroughly.

Cervical Sample Taker Database (CSTD)

Responsibilities:

It is a practice administrator's responsibility to monitor sample taker performance, enrol new sample takers in practice onto the CSTD and ensure that their information is kept up to date (including change of name, place of work and any update of email address).

It is a sample taker's responsibility to record and upload evidence of their update training.

Work is ongoing on the database to enable all sample takers to obtain their own statistics. To do this you must ensure you use your correct sample taker code. It is important we are informed when you become a qualified sample taker, your status must be updated from trainee on the system and the "T" removed from your code.

Brush in Vial

We have noticed an increased number of vials with the brush still remaining inside. Please ensure the brush is "mashed and bashed" in the vial and then discarded, this also includes endocervical brushes.

DO NOT LEAVE ANY BRUSHES IN THE VIAL.

In line with NHSCSP Acceptance Guidance, samples that contain a brush will still be processed but if HPV negative will be reported as "HPV Unavailable" and a repeat requested in 3 months. If HPV positive and cytology negative, will be reported as "Unsatisfactory" with a repeat requested in 3 months. The sample will only be reported if the cytology is abnormal.

Did you know..

- ...Patient invitation and result letters are not sent out by the laboratory, they are sent by Cervical Screening Administration Service (CSAS) in Leeds. www.csas.nhs.uk
- ...Following a direct referral, the referring Colposcopy unit books the appointment and informs the patient of the date and time.
- ...Once you submit an ICE request it is sent electronically to the laboratory. If for whatever reason you do not take the sample you must inform the lab ASAP by calling the freephone helpline on 08009537610.

Deleting the request in your clinical system does not cancel the request that has already been sent electronically to the laboratory.

...the CSP mailboxes are monitored by different personnel. Here is a breakdown of the appropriate contact details and their purpose:

General Enquires (including patient history checks/test due dates) call freephone helpline on 08009537610.

Supplies - replenishment of pink bags, ICE paper, sample vials, brushes and sample bags are ordered via email at ghnt.hpv-supplies@nhs.net. Staff can request a limited emergency supply of ICE paper and pink bags for **HPV use only** from the HPV courier.

Please **do not** put notes requesting stock in with your samples. Due to changes in the laboratory reception workflow, these notes can no longer be actioned.
